RECURRING DONATIONS POLICY

1. Parties

This Policy governs the relationship between:

2. Consent to Recurring Donations

- 2.1. The Donor provides consent to establish recurring charges by checking the corresponding box on the payment page (the checkbox is unticked by default).
- 2.2. By clicking the "Proceed to Payment" button, the Donor confirms consent to automatic monthly charges in favor of the Foundation in accordance with this Policy.

3. Charges and Schedule

- 3.1. The initial charge is processed on the date the subscription is created.
- 3.2. Subsequent charges are processed automatically once a month, on the same calendar day as the initial charge, unless otherwise determined by the payment system.
- 3.3. The donation amount is selected by the Donor from the available options and remains unchanged until canceled or modified by the Donor.

4. Cancellation of Recurring Donations

- 4.1. The Donor has the right to cancel recurring donations at any time without providing reasons.
- 4.2. Cancellation is carried out independently through the personal account (self-service), without contacting support.
- 4.3. Cancellation takes effect immediately after confirmation, and no further charges are made.

5. Refunds

- 5.1. Donations are voluntary in nature and are, as a general rule, non-refundable.
- 5.2. Exceptions may apply in cases of technical error, system failure, or unauthorized transaction.
- 5.3. To request a refund, the Donor must contact the Foundation within 14 calendar days from the date of the disputed charge.
